WHEREAS, Minnesota Statutes mandate that all counties certify a proposed levy and special levies to the County Administrator and adopt a proposed budget on or before September 30, 2022, and

WHEREAS, the Wright County Board of Commissioners has received and reviewed the proposed operating and capital improvement budgets and levy requirements submitted by Departments and agencies for calendar year 2023, and

WHEREAS, Wright County has sufficient fund balance in the debt service fund as of September 30, 2022, the County Board hereby approves foregoing the levying of at least 105% of total debt service requirements for principal and interest payments due in 2023 as required by Minnesota State Statute § 475.61, and

NOW THEREFORE BE IT RESOLVED, that said Board of Commissioners hereby adopts the proposed 2023 operating and capital improvement budget and certifies a proposed property tax levy to the County Administrator in the amount of \$90,652,259 for fiscal year 2023 for consideration during the ensuing months.
